Booking Data

• Bookings can contain individual information in the booking details provide by the third party making bookings

How we use the information

• Processing Launch Bookings

- Maintain Launch Schedule
- Restrict access to named users
- Define what data registered users can access
- Handle queries relating to current scheduled work
- Handle queries relating to completed work
- Manage H&S Incidents
- Manage defects and repairs
- Provide business information to ESL management
- Provide information in the investigation of H&S incidents
- Where we need to comply with a legal obligation

How long do we hold your information

- Company details are held as long as the service provided information is retained.
- Individual user login information is held for 3 months and then a summary is retained thereafter.
- Schedule and booking data is held indefinitely.
- Unless you have not given consent we retain your data "as-is" after you leave your place of work (it is your right to be "forgotten")

How we hold this information

We use a dedicated web service provider and the information is held in a secure file system.

Disclosure of your information

Your data is only disclosed to

- Registered users with schedule, or booking view. Information is limited to Pilot Names and comments for current bookings and schedules
- ESL Staff can access data as required by their duties as defined by their security permissions.
- ESL Management, to carry out their legitimate interests

What is the legal basis for processing this information

We retain your data to allow Estuary Services Ltd to fulfil it legitimate interests. Where other information is from time to time collected for short term use, this will be done based upon your consent.

Your Rights

As an individual you have the right to obtain a copy of the information we hold on you. You may access your data by contacting the Operation Manager at Estuary Services in writing.

Withdrawal of consent

Where items are not contractual, or part of an ongoing H&S investigation, you have the right to withdraw your consent for the use of your data.

Automated decision making processes

We do not use your information in any automated decision making process, nor in any external marketing campaigns.
